for a child under Sixteen years of age

NOTES

HOW TO COMPLETE FORM

- Sections 1, 3, 5, 6 and 10 on this form must be completed on behalf of all children.

Section 2 must also be completed where applicable.

The form should be clearly written in applicant's own handwriting using BLOCK CAPITALS for all names.

- CERTIFICATION OF APPLICATION.** The application must be certified and sponsored in Section 10 by the Passport Officer, any Member of Parliament, Magistrate, Justice of the Peace, Minister of Religion, Police Officer (Gazetted Rank), Bank Manager, Medical Practitioner, Lawyer, School Principal or Senior Civil Servant who has been personally acquainted with the applicant.

- PHOTOGRAPHS.** Two copies of a recent photograph of the child must be included with the application. These must be taken full face, without hat, on a white background and must not be mounted. The size must not be more than 5 centimetres by 5 centimetres. The person who certifies the application is also required to endorse the reverse side of one copy with the words: **"I certify that this is a true photograph of"** and add his/her signature. All photographs included with an application become the property of the Government of Barbados when it is lodged.

4. DOCUMENTS TO BE PRODUCED

- If the child was born in Barbados, child's Birth Certificate. In cases where the name is not included on Birth Certificate, Baptismal Certificate must also be produced.

- Persons born outside Barbados –

It must be noted that any person born outside of Barbados may not be issued with a Barbados Passport unless he is recognized or registered as a Citizen of Barbados by the Ministry.

- Citizenship by descent – Letter of recognition as Citizen of Barbados/Certificate of Citizenship by Descent.
- Citizenship by Naturalization or Registration – The appropriate Registration Certificate.

(N.B. – Citizens of Barbados who apply for passports in Barbados must produce the Minor's Identification Card or evidence of registration if the card is not available)

- Children under 18 years of age may not be granted passports facilities without the written consent of the parent.

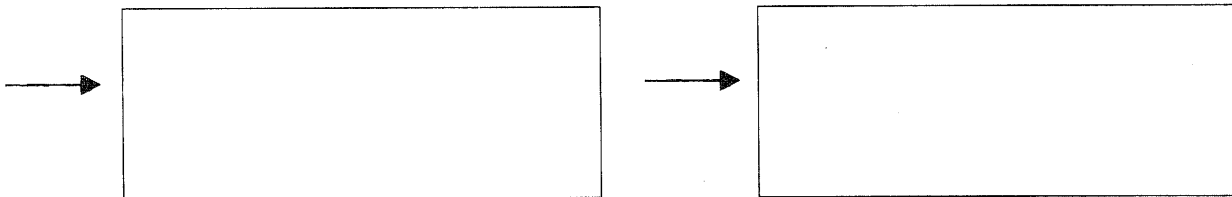
(N.B. – Any person claiming legal custody must produce the court order committing the child to that person's custody.)

- A change of name except in cases of adoption when the name is not required, must be substantiated by the production of evidence showing that a *bona fide* change has been made.
- If other children under 16 years are to be included in the passport (see Section 7 of the form) the same documentation must be produced.

APPLICATION FORM "B" To be completed in ink in the applicant's own handwriting by or with the written consent of the legal guardian of the child. There are good reasons for this. Except in cases of physical disability. Failure to comply may lead to delay in the issue of passport.
